

**CANNON MOUNTAIN CHILDCARE
LIABILITY RELEASE**

I, _____, the parent or guardian of _____, hereby agree to RELEASE Cannon Mountain, the State of New Hampshire, its employees and assignees ("Cannon") from any and all liability for damage and personal injury to my child or my child's property, including those resulting from Cannon's own acts of NEGLIGENCE. I understand that Cannon is not responsible for the consequences of its own NEGLIGENCE, that is; its failure to use reasonable care in any way in the operation of this childcare center, facilities, equipment, and premises. I acknowledge that I am freely and expressly assuming and accepting any and all risks of damages, personal injury, or death as the parent or guardian of a child enrolled in the childcare center.

Further, I authorize anyone working at the childcare center to call for such medical care for my child or to transport my child to a clinic or hospital, is, in opinion of anyone working at the childcare center, medical attention is needed for my child. This Release also authorizes a licensed physician, other recognized first aid room staff member or first responder to carry out emergency medical care deemed necessary for my child in an emergency where obtaining permission from me is not possible under the circumstances. I agree that upon transporting my child to any medical facility, clinic, or hospital, that the responsibility of Cannon shall be totally fulfilled and Cannon shall not have any further responsibility for my child.

I agree to pay all costs associated with such medical care and related transportation for my child and agree to INDEMNIFY and HOLD HARMLESS Cannon from any costs incurred therein.

I agree that any claims that I may bring to any reason against Cannon relating to an event that occurs at the childcare center shall be submitted to the jurisdiction of the State of New Hampshire Superior Court or Federal Court. Any such claim brought shall be determined in accordance with New Hampshire law. I further agree that is any portion of this Release is determined to be unenforceable by a court of law, all other parts of the Releases shall remain in full force and effect.

I consent to use by Cannon of any pictures (video and print) for commercial purpose, or otherwise, of my child in connection with the actives of the childcare center without restrictions as to frequency, duration or medium.

I have read the above paragraphs and fully understand them. I understand that this is a RELEASE OF LIABILITY, which will legally prevent me or any other person from filing suit, or making any other claims for damages in the event of personal injury, death, or property damage. I freely and voluntarily enter into this Release. I intend this Release to be interpreted as broadly as permissible by law and understand that it is not intended to assert any claims or defenses prohibited by law.

As a parent/guardian of the child named below, I acknowledge that I am authorized to sign this Release for the child and I agree to be bound by its terms. I hereby agree to INDEMNIFY, DEFEND and HOLD HARMLESS Cannon from any claim, suit, expense or loss which arises out of the child's participation in the childcare center or which arises out of the child's presence on Cannon's premises.
